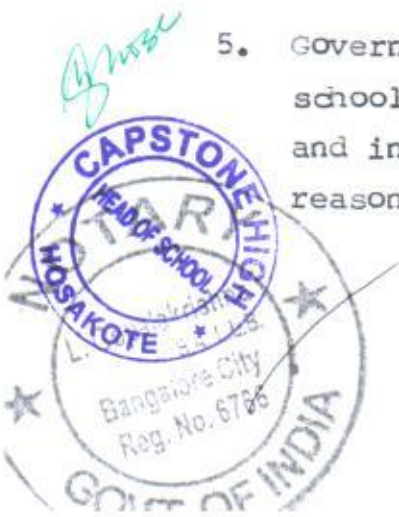

1. This registration is governed by the ingredients in Rule 3 (5) (d) of the Karnataka Education Institutions (Private Education Institutions Regulation, Classification) Rules, 1997.
2. In accordance with Rule 4, 5, 6 and 8 of the Karnataka Education Institutions (Classification, Control and Fixation of Syllabus, etc., ) Regulations, 1995, as  
\* safety measure, the School Building compulsorily possess ceiling of excellent quality and must have provision for free air and light. Separate lavatories/bathrooms for male and female children must be provided. Must provide drinking water. Shall construct compound for safety of children into the school compound by fencing hazardous places in the premises of the school and must take up safety measures necessarily to prevent fire mishaps.
3. Should not open extra sections without prior permission of Government in any circumstances by the said Education Institution.
4. School shall be opened in the medium sanctioned and in the same place as per Section 41 (5) of the Karnataka Education Act and there is no opportunity to shift the place for any reason.
5. Governing Council to which the permission is issued to run school the same Governing shall run school in the same name and in the same place and shall not transfer/assign for any reason without prior permission of the Government.



6. This Education Institution shall comply all Government Orders and rules issued in respect of Education Institutions in time to time and that are in force. Shall ~~not~~ comply rules and Acts coming under the Karnataka Education Ordinance 1983 (Karnataka Act Number.1995) without fail.
- 7.. Registration of of this primary school is permanently without-aid as per Government Notification No.ED.175.,P.M.C. 95 dated 07-09-98 and 29-12-98.
8. Shall adhere rules of Karnataka ~~Educational~~ Private Education Institutions (Disciplinary and Control) Rules, 1999 without fail and shall abide by the same.
9. Shall only teach text- books prescribed by the Department in accordance with Karnataka Education Institutions (Clasification, Control and Fixation of Syllabus) Rules, 1995 and Government and shall take up action so that the ~~lessor books~~ text books should not burden.
10. Shall compulsorily publish a borcure of the detailsof fees to be recovered from the students/parents in the school in Notice Board of the School under Rule 10 (4) and a copy of the same shall be filed to the Block Education Officers/Deputy Director.
11. Shall compulsorily follow rules of Karnataka Education Institution (Regulation of Certain Fees and Donations) Rules, 1999 of Government Notification Number.ED.39. Multi.99 dated: 14-03-2000 and should not collect any contribution as per this rule.



12. Shall file application to the Regularizing Authority as per Government Notification No.ED.137.MULTI.98 BANGALORE dated: 19-05-99 to ~~ps~~ possess renewal of recognition as per ED.131.MULTI.98, Bangalore, dated ~~19x0x~~ 04-11-99 and as per Section 36 to 39 of Karnataka Education Act, 1983 (Act 1 of 1995) within 2 months of the permission obtained and ~~stabilize~~ the Institution shall keep ~~se~~ fixed security deposit to start school in joint account of the Deputy Director of the District and Secretary of the Board of Management.
13. Shall conduct 1st to 5th Classes in Kannada or vernacular (mother tongue) language medium of children and must follow language policy as per Government Order No.ED.28.P.G.C. 94 dated: 29-04-94. Subject to the condition that if this language policy is not followed and violated, this order will be cancelled.
14. Shall follow ratio of children and teachers in every class to which permission is issued under rule of Annexure-5 of the Government Notification No.ED.52.MULTI.99 dated: 02-02-2000.
15. Shall appoint only Teachers having educational qualification as per rules of department and having training.
16. Shall provide benches, tables, apparatus, library and other facilities required for the school within one year and play ground school buildings in three years as per Karnataka Education Bill and rules.
17. Shall follow school working timing and days as per rules of Department.
18. Must communicate admission of students and opening of school within two months of commencement of academic year or registered school to this office. In case school is not opened, and any conditions are not complied, this order stands cancelled automatically.



19. Already 1st to 7th Standards are in Kannada Medium, shall look after so that no any harm would cause to the students of Kannada Medium from 1st Standard to 5th standard from the sanction of ~~English Medium~~ of Higher Primary School of English Medium.
20. Shall ~~not~~ compulsorily follow instructions of Government Circular No.ED.27/S.E.P.03 dated: 13-02-2003. To open service book of staffs appointed in the school and record details of service of teachers in that and to maintain compulsorily.
21. To employ teachers for census work without fail.
22. To reserve strength of roll of students as per Education Act in each class and should not exceed 50 Number of students.
23. Excluding Kannada/mother tongue medium book in 1st to 5th standard, no any books of English medium should not be used in the class in extra.
24. Any records filed in the proposal are found false records, this registration will be cancelled.
25. Shall protect safety of children and building as per Letter No.A.D.M.2/M.S.20/2007-08 dated: 10-12-2009 of the Director (Primary School).
26. Children in the school should not be punished in any manner and ~~no~~ ~~not~~ should not insult.
27. Shall adhere instructions as per Circular Number.AD.2/Vehicle Circulat.01/2010-11 dated: 22-12-2010 of this Office.
28. Shall provide fire extinguishers mandatorily.
