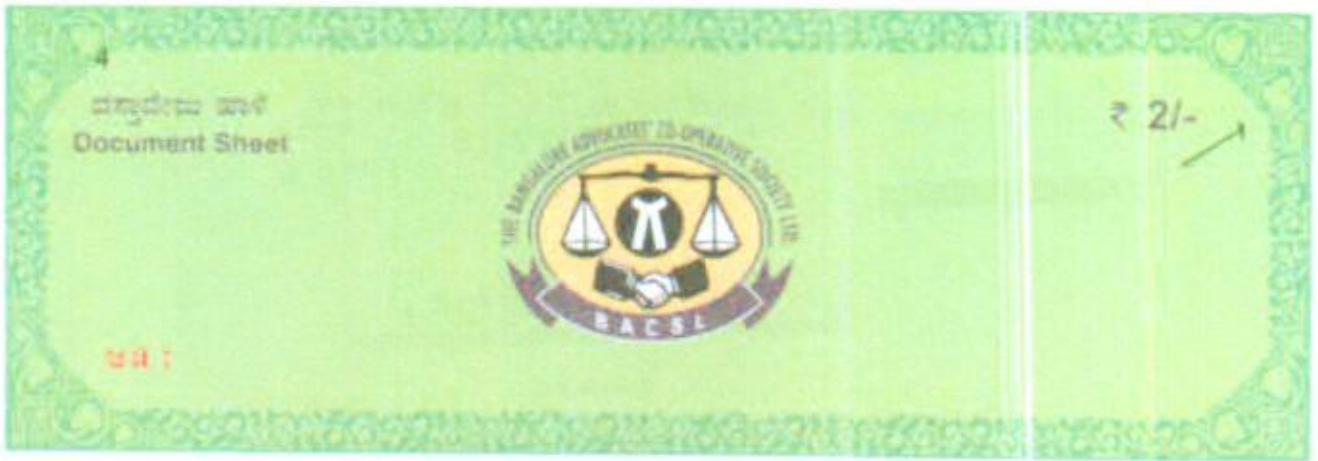

To establish run and maintain educational institutions for the benefit of religious minority (Muslims) and linguistic minorities and other backward classes for their upliftment in the field of education and to face the globalization of education at par with others.

The clause 3 (i) shall stand deleted and in its place the following clause will be inserted

3.(i) To establish run and administer educational institutions primarily for the benefit of the Muslim Community and also the society at large.

(ii) The Educational Institutions established by the "S.A SAMAD EDUCATIONAL TRUST" are primarily for the benefit of the Muslim Minority Community and also the society at large.

This supplementary deed is registered with the Original Deed no. No. HLS-4- 00143/2013-14 dated 29-06-2013 of Book-IV and the same is stored in CD No. HLSD 80, as amended by the Amendment to the Trust Deed dated 4<sup>th</sup> of December 2014 which is registered as documents No 458/2014-2015 in the office of the Sub-Registrar, Ulsoor, Bangalore.

That it is hereby resolved that the original Trust Deed of "S.A SAMAD EDUCATIONAL TRUST" shall be amended as per the clauses as are made herein above which shall have the same effect and bearing as if the original clauses of the main Trust Deed and that these clauses shall have their effect from the date of registration of Trust.

That all the Trustees as said above have agreed for this modification and incorporation of clauses in continuation to the original Deed executed on 29-06-2013, hence this Deed of Addendum is being executed on this the 24th November 2017.
